

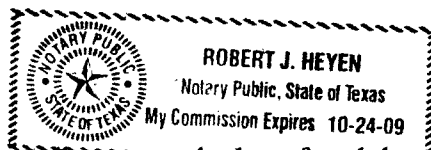
### RECALL PETITION

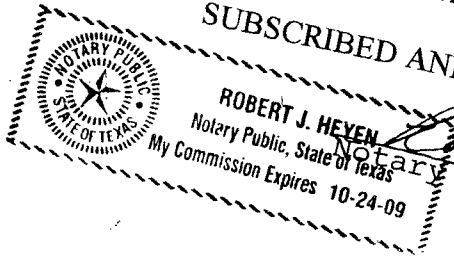
